SEMINAR TO SHARE REGIONAL EXPERIENCES ON THE IMPLEMENTATION OF NUMBER PORTABILITY IN THE AMERICAS

The XVII Meeting of the Permanent Consultative Committee I: Telecommunications/Information and Communications Technologies (PCC.I),

CONSIDERING:

That the terms of reference of the Working Group on Deployment of Technologies and Services (WGDTS) approved by Resolution PCC.I/ RES.163 (XVI-10), and specifically of the Rapporteurship on "Telecommunications Numbering and Addressing" that consider, among others, the study and assessment of technical issues related to portability,

TAKING INTO ACCOUNT:

- a) That at the VII Meeting of the Permanent Consultative Committee I: Telecommunications standardization (PCC.I), in September of 2005 in the city of Washington, DC, United States of America, and also at the XIII Meeting of the Permanent Consultative Committee I: Telecommunication standardization (PCC.I), in August of 2008 in Puerto Iguazú, Misiones, Argentina, the workshop on number portability was carried out;
- b) That the topic prevails in the regulatory Agenda of the countries of the region; that some countries of the region implemented portability at the time; others are analyzing the viability of the topic or are about to carry it out;
- c) That there are experiences and/or relevant regional models about number portability that involve a technical, operational and regulatory treatment (Canada, Brazil, Mexico and United States of America), as well as others;
- d) That sharing said experiences and/or models will help the countries of the region to have more elements to assess the viability regarding whether the implementation of number portability in their countries is viable or not, and will provide feedback to the Technical Notebook on the subject,

RESOLVES:

- 1. To hold a Seminar during the Working Group on Deployment of Technologies and Services (WGDTS) sessions to share experiences and/or regional models on Number Portability in the Americas, in order to contribute to the sharing of experiences in the framework of the XVIII Meeting of PCC.I, which will be coordinated by the Rapporteur of the Group.
- 2. To carry out the Seminar in conformity with the agenda included as annex 1 to this Resolution.
