PCC.I/RES. 303 (XXXV-19)²

WORKSHOP "CONNECTING THE UNCONNECTED IN RURAL AND REMOTE AREAS"

The 35 Meeting of the Permanent Consultative Committee I: Telecommunications/Information and Communication Technologies (PCC.I),

CONSIDERING:

- a) That one of the objectives of PCC.I for 2018-2022, according to resolution CITEI/RES. 85 (VII-18) approved at the VII Regular Meeting of the Assembly of CITEI, is the identification of comprehensive strategies related to access and financing mechanisms for the expansion and connectivity of networks, such as universal service, public investment, among others, with specific measures in rural areas, remote or difficult to access, with a view to improving their affordability.
- b) That in the 34th meeting of the PCC.I the WGPR approved the workplan of the Rapporteurship on Broadband, universal access, digital inclusion and gender equality, in which it was defined that a workshop on infrastructure development and service provision in rural and remote areas would be organized in an upcoming meeting of PCC.I to enable discussions on public policy aspects, broadband plans, resources that can contribute to universal access, etc.
- c) That in 2018 the General Secretariat of the Organization of the American States (OAS), through the Inter-American Telecommunication Commission (CITEI), and the Internet Society signed a collaboration agreement to promote the creation of new community networks, understood as alternative and complementary solutions to other models to connect the unconnected and strengthen regional efforts to reduce the digital divide.
- d) That the deployment and the expansion of community networks in the region depend on several variables such as the existence of efficient and sustainable organizations in the local level, the availability of technical capabilities, the amount of resources available, environmental conditions, as well as regulatory and institutional settings that might favor or impair the development of such networks.

RESOLVES:

1. To approve the holding of a workshop on "**CONNECTING THE UNCONNECTED IN RURAL AND REMOTE AREAS**", on Tuesday of the 36 Meeting of PCC.I.
2. That the coordination of said seminar will be undertaken by the Internet Society, the Rapporteurship on Broadband, universal access, digital inclusion and gender equality of WGPR / PCC.I, in cooperation with CITEI's Secretariat.
3. To approve the draft agenda attached to this resolution.

The 35 Meeting of Permanent Consultative Committee I: Telecommunications/Information and Communication Technologies (PCC.I),

CONSIDERING:

- a) That Resolution CITELE RES. 295 (XXXIII-18) established the structure and terms of reference for the Working Groups and Rapporteurships of PCC.I, including the structure of the Rapporteurship on Technological Innovation, Digital Economy, Internet of Things, Smart Cities and Communities;
- b) That in accordance with CITELE RES. 295 (XXXIII-18) the mandate of the Rapporteurship on Technological Innovation, Digital Economy, Internet of Things, Smart Cities and Communities is to promote the discussion and exchange of information on aspects related to technological innovation and the digital ecosystem, in order to promote the development of the digital economy, the Internet of Things, and the Smart Cities

RECOGNIZING:

- a) That it is within the Terms of Reference of the Work Plan of the Rapporteurship on Technological Innovation, Digital Economy, Internet of Things, Smart Cities and Communities to conduct activities for capacity strengthening of the Member States in the technological trends of telecommunications and ICT.
- b) That it is also part of the Terms of Reference of the Work Plan of the Rapporteurship on Technological Innovation, Digital Economy, Internet of Things, Smart Cities and Communities to

establish liaisons with actors of the digital economy ecosystem, such as operators, service providers, standards bodies and industry forums, as needed, in order to anticipate possible innovations in technologies and services.

RECOGNIZING FURTHER:

- a) That Work Plan of the Rapporteurship on Technological Innovation, Digital Economy, Internet of Things, Smart Cities and Communities calls for the continued collection and analysis of emerging new telecommunication/ICT technologies and their impact in the Americas region and beyond, with topics to include AI, IoT, ITS, SDN, M2M, LTE Broadcast and 5G technologies, in particular collecting information on the advancement of new technologies in networks in the different administrations of CITEL;
- b) That it is programmed within the Work Plan of the Rapporteurship on Technological Innovation, Digital Economy, Internet of Things, Smart Cities and Communities to hold a seminar on 5G infrastructure and services, including IoT/Smart Cities with participation from governments, the private sector, and other interested parties at the 36 PCC.I Meeting in 2020;

CONSIDERING:

- a) That many Member States in the Americas region currently are or will be contemplating their respective national spectrum policy frameworks related to 5G deployment, including the allocation and licensing of spectrum;
- b) That several past meetings of PCC.I have studied and evaluated various information documents that addressed technical and policy issues related to 5G communications and the anticipated socio-economic benefits of applications enabled by these networks;

RESOLVES:

- 1. To approve an extended half day (three sessions) Seminar on “5G: Opportunities and Challenges in the Americas,” to take place on the first day of the 36 Meeting of the Permanent Consultative Committee I: Telecommunications, Information and Communications Technology.
- 2. To hold this seminar without incurring any costs for CITEL.
- 3. To designate the Rapporteurs of the Rapporteurship on Technological Innovation, Ms. Amy Alvarez (AT&T), and Ms. Milene Franco Pereira (Qualcomm) as CITEL’s contact points to coordinate the Seminar.
- 4. To approve the list of topics included in the Annex, as a starting point for discussions on the issues to be addressed during the Seminar.
